TERMS AND CONDITIONS

1) The voucher redemption is open to all shoppers except retail tenants and employees of retail tenants.

- 2) Redemption of voucher will be at the L3 Information Counter (close to BabySPA) daily from 10.00am 9.30pm (unless otherwise stated on <u>website</u>).
- 3) Only the following E-Waste are accepted:
 - Batteries (AA, AAA, AAAA, D, C, 9-volt, Button Cell only) circumference ≤ 50mm
 - Light Bulbs circumference ≤ 100mm
 - ICT equipment: Printers, power banks, computers & laptops, mobile phones & tablets, network & set-top boxes, TVs & desktop monitors – devices must be able to fit through a 500mm x 250mm slot
 - ICT Peripherals such as Mouse, Keyboards, Cables and Adaptors can be disposed together with the main regulated ICT product

- 4) Shoppers would need to notify a Customer Service Officer that they are recycling an e-waste item before dropping the e-waste item into the recycling bin to qualify. Redemption must be made in person.
- 5) All shoppers are limited to a maximum of 1 redemption per calendar month.
- 6) Limited redemptions available per month. Redemption is on first-come, first-served basis, while stocks last.
- 7) HarbourFront Centre (The Organiser) is not obliged to replace or compensate for any lost, defaced, damaged or stolen voucher(s).
- 8) Redemption items must be taken as provided and are not exchangeable for cash, or other goods and services. Redemption items are not exchangeable once redemption process is complete.
- 9) Shoppers must be at least 16 years of age as at 1st June 2022 to participate in any promotions or redemption events forming part of the Promotion. The Organiser reserves the right to request for proof of age at any time.

- 10) Redemptions will be accepted only upon being fully furnished with the shopper's particulars (name (as per NRIC), gender, email address, mobile number, birth date, postal code).
