**TERMS AND CONDITIONS FOR

- 1) The challenge period is from **19<sup>th</sup> November to 31<sup>st</sup> December 2021** and will be held at #03-15, The Escape Artist outlet, at HarbourFront Centre.
- 2) It is open to all Singaporeans and residents of Singapore except employees of Mapletree Investments Pte Ltd and The Escape Artist, its advertising agencies, retail tenants of HarbourFront Centre (The Organiser) and their immediate families.
- 3) The challenge is only applicable on “Night before the Storm” escape room theme.
